Explanation of budgetary expenditures for the grant period

The YWCA did not expend the full grant in the first grant period due to the program not being up and running until June, 2015. We are awaiting final approval on non-federal share waiver request for the above grant period.

2. Average monthly enrollment as a percentage of funded enrollment

Funded enrollment - 155.

Average monthly enrollment is 85% of funded enrollment (June 2015 through August 2016)

Note: This was the start-up period/year with time spent recruiting and identifying eligible children for the program.

3. Information about parent engagement activities

Parent engagement is a critical part of our program. YWCA EHS offers a variety of venues for parents to become involved. Meetings at each center or site provide opportunities for parents to share their experience and knowledge. Topics addressed are a result of input from parents at enrollment and orientation. Specific topics and interests are identified through an enrollment interest survey, input from center committee meetings and individual contacts with families. Support groups are formed to address specific concerns of parents. The frequency of family activities and events is determined by center. They decide on the number of parent events and contacts at their program in order to meet parents' needs and choices. YWCA EHS family support coordinators work with each site to provide technical assistance and to monitor all family support activities in the center and with families enrolled in the center.

Center Committees

All parents who are enrolled at the center are members of the Center Committee. Parents are elected by their peers as leaders at each Head Start site. The Center Committee is responsible for a variety of decisions that affect their site including planning educational events, leading parent meetings, and designating and approving uses of the parent funds. Centers approach parent leadership in various ways, depending on the size of their center. Parents volunteer in the classrooms, participate on interview teams, make recommendations regarding hiring, recommend books or toys for Center or site lending libraries, and participate in developing and implementing their child's learning goals and activities. Annual parent forums and surveys solicit input for training, parent involvement, and the program-wide community and self-assessments.

Policy Council

Each site selects one parent representative and one or more alternates to serve on the YWCA EHS Policy Council. This forum offers parents a role in advocacy and decision-making that affects the operation of Early Head Start. For many parents, membership on the Policy Council results in developing further leadership and advocacy skills. Parents periodically attend state, regional, and national training conferences, representing the YWCA Early Head Start program and Policy Council.

5. School Readiness

The YWCA provides a comprehensive program that implements curriculum fidelity, individualized assessments and screenings, and effective teacher/child interactions through primary caregiving. The critical interactions of teachers, families and children prepare infants and toddlers to succeed when transitioned into preschool programs when they turn three years of age and later, transition to kindergarten. Children were assessed using the ongoing assessment tool Teaching Strategies GOLD. Teachers observe children frequently throughout the year as they participate in everyday experiences. Four times a year, teachers evaluate each child's individualized developmental progress through their documentation including but not limited to observation notes, work samples, pictures, videos, and checklists. The program's school readiness goals are aligned with GOLD, the State of Ohio Early Learning and Developmental Standards and the Head Start Early Learning Framework.

The following demonstrates the percentage of children served at the YWCA Canton Early Head Start Childcare and Family Childcare Program during the 2015 program year that were meeting or exceeding widely held developmental expectations and the end of the 2015 program year.



Data shows information in developmental areas where children are meeting widely held expectations and areas that will require future planning to ensure positive outcomes for children. Extended focus will be on the area of mathematics, providing training and technical assistance to define what math looks like to an infant or toddler. Ongoing monitoring of GOLD will ensure individualization for each child and alignment with daily activity plans.
